Dear Ladies and Gentlement, Dear friends of luge,

The FIL Executive Board met for their fall meeting September 17-18, 2019 in Washington DC/USA.

The focus of the discussions was the preparation of the coming season, the meeting and composition of the Working Group "Strategy of the FIL" and the fundamental discussion regarding the FIL and Olympic luge.

I would like to inform you about several important decisions as follows:

- Athletes' prize money artificial and natural track for the 2019/20 season (see enclosures 1 and 2)

Even though savings were made in the FIL budget, the athletes' prize money remained unchanged compared to the 2018/19 season. As explained at the FIL Congress in Ljubljana in June this year by Vice President Harald Steyrer, we want to exempt sport operations and athletes as much as possible from the absolutely necessary cost-cutting measures in the FIL budget.

Doping tests

Doping tests will also be carried out this season. The FIL has outsourced this area to the International Testing Agency (ITA).

- Assignment of the officials (FIL Representative, jury, and TDs) for the 2019/20 season artificial and natural track

The organizers of the competitions and the officials have been or will be informed separately.

- 2020/21 FIL competition calendar artificial track general class

In coordination with the IBSF, Sports Director Maria-Luise Rainer and the working group "Calendar Artificial Track" prepared a draft of the 2020/21 events schedule, which was also discussed by the Executive Board. The aim is to publish the 2020/21 events schedule as soon as the end of November this year in order to enable all NFs to plan accordingly for the pre-Olympic season.

Working group "Strategy of the FIL"

As presented at this year's FIL Congress, a WG Strategy of the FIL will deal with the short, medium, and long-term orientation of the FIL.

All national federations will be involved in this development and work process. The first meeting of this WG will take place during the Viessmann World Cup in Innsbruck-Igls.

The aim of the working group is to submit a prepared strategy paper to the 2020 FIL Congress in Berchtesgaden for approval.

- FIL and the Olympic luge disciplines - policy statement

The Executive Board has again clearly stated its intention to continue efforts to have natural track sport added into the Olympic program. The chances for this with Milano / Cortina as venue of the 2026 Olympic Winter Games are certainly much greater.

Based on the decision of the IOC concerning the inclusion of new sports / disciplines in the Winter Olympic program (Agenda 2020, New Norm), the Executive Board unanimously approved the following resolution, which I would like to share with you:

The Executive Board supports and is in favor of the inclusion of natural track luge in the Olympic program at the 2026 OWG in Milano / Cortina.

The existing formats in natural track luge must be critically examined by the WG Development Natural Track Sport and possibly re-evaluated.

The current 4 Olympic disciplines (men's singles, women's singles, doubles, Team Relay) must remain untouched.

Efforts to include women's doubles artificial track in the 2026 Olympic program must be pursued seriously and consistently (gender equality!), but in any case, requires an increase in the allocated number of athletes (currently 106 athletes) by the IOC

In addition, we would like to provide you with the following information:

- The obligatory memo "Information about the start of the season artificial track 2019/20" has already been brought to the attention of every NF. I would like to take this opportunity ask you again to please pay attention to this important information concerning the sports operations.
- The 2020 Asian Championships will take place in PyeongChang/KOR
 December 19-21, 2019 following a motion from the Korea Luge Federation. The invitation will be available soon at www.fil-luge.org.

Rough schedule of the charter flight to Sochi/RUS:

Departure: Frankfurt – Sochi Adler on Monday, February 3, 2020, around 10:00 am

Return flight: Sochi Adler – Frankfurt on Monday, February 17, 2020, around 11:00 am

Detailed information will follow as soon as it comes from the Russian luge federation.

- Information on application for staging artificial and natural luge track competitions and the FIL annual accreditation is attached (see enclosures 3, 4, 5).
- We point out the <u>new FIL data protection declaration for athletes</u>.

 Each athlete must send this signed to the FIL office and carry <u>a copy of this new declaration</u> along with the FIL license throughout the entire winter (see enclosure 6).
- The 68th FIL Congress will take place in in Berchtesgaden/GER on Monday, June 15 and Tuesday 16, 2020.

The schedule for the preparation of the 68th FIL Congress was approved by the Executive Board (see enclosure 7).

- The commission meetings will be held in St. Leonhard, Salzburg/AUT from April 16-19, 2020.

Explanation Rookies and Additional Starter

Rookies means newcomer to the track:

Newcomers are athletes that have not yet participated in a FIL competition (WC/NC/FIL championships) in the General Class in their discipline on this track. For doubles, this applies if the team in the same composition has never before participated in a doubles competition in the General Class at this track. Newcomers to a track will receive an extra training run from abbreviated start height on the first day of training

Additional Starter: (IRO § 3, 3.3) Regulation for eligibility

In addition of the normal world cup starter field (Men's 5, Women's 4 and Doubles 3 competitors), each NFs is allowed to register additional starters (in Men's 3, Women 2, Doubles 2) which are allowed to compete in Nations Cup only and cannot qualify for the world cup.

FIL annual accreditations 2019/2020 – artificial track Information for National Federations

> Validity:

- 2019/2020 FIL annual accreditations artificial track are valid for all Viessmann World Cups including Viessmann Team Relay World Cups presented by BMW and **BMW Sprint World Cup**
- Accreditations are usually not required for junior events.

> Application:

FIL annual accreditations must be applied for via the FIL online registration tool (first entry "Annual Accreditation 2019/2020") just like a registration for a competition. Deadline: September 30, 2019

> Pick-up:

At the 1st Viessmann World Cup in Innsbruck, the company Plaras will operate an accreditation office. There you may:

- Pick up the accreditations applied for through the online registration
- Have accreditations corrected if necessary
- Have new team members accredited and photographed

> Photos:

Accreditations will only be issued with a photo. In case no photo is available from previous seasons, you may e-mail a photo (fischer@fil-luge.org) or have it taken at the 1st Viessmann World Cup in Innsbruck. Please note that no headgear is allowed on accreditation photos.

> ..Green Card"

As in the previous season, each National Federation with an team captain will receive a "Green Card", which grants access to the VIP area for one person. It is only valid in combination with a team accreditation of the same nation. The Green Card is transferable within the team, but not within the same day (1 person per day).
