Dear Ladies and Gentlemen,
Dear Friends of luge!

The FIL Executive Board met on September 17-18, 2025, for its fall meeting in Munich, Germany.

The focus of the discussions was on preparations for the coming season and the handling of related motions.

I would like to inform you of some important decisions and resolutions as follows:

- **Athlete prize money for track and alpine luge for the 2025/26 season**
(see enclosures 1 and 2)
- **Appointment of officials (FIL representatives) for the 2025/26 season in artificial track and Alpine luge (European Championships, Junior World Championships)**

The organizers of the competitions and the officials will be or have already been informed separately.

- **Artificial track sports calendar for the 2026/27 to 2029/30 seasons**

The Executive Board **has confirmed the artificial track sports calendar (general class, juniors, youth A) up to and including 2029/30 in principle.** Further information on this subject will be provided separately.

- **Pre-homologation (test runs) and homologation of the track in Cortina**

In accordance with IRO and in close consultation with the Artificial Track Construction Commission and our legal expert, the Executive Board has passed the following resolution. We would like to bring the original (English wording) to your attention:

The race track is commissioned by the FIL Executive Board because the required test runs at the end of March 2025, according to IRO 2024, supplement 1, 3.6, could be carried out successfully. The final report on the pre-homologation, dated April 1, 2025, is an integral part.

The final commissioning of the entire track facility will be issued after completion and full functionality of the other requirements (e.g., video surveillance, audio system, timing system...), written down by the Track Construction Commission.

The FIL assumes no responsibility for the accuracy of calculations or for the execution of works for constructing this track and the facilities.

The FIL accepts no liability for the entire homologation process. This exclusion of liability must be noted in the written notification to the track operator. In their homologation application, the track operator must provide evidence of liability insurance with adequate coverage by submitting a copy of the insurance policy. Sufficient insurance coverage must also be proven by those involved in the construction or repair of the track to the track operator and the FIL.

This executive board resolution also applies, with the necessary adjustments, to the upcoming homologation process in Innsbruck-Igls.

- **Schedule until the 74th FIL Congress 2026 in Berchtesgaden**

For your information, here is the detailed schedule until the FIL Congress 2026 (enclosure 3).

- The **74th FIL Congress 2026** will take place on **Monday, June 8, 2026, and Tuesday, June 9, 2026.**
- The **commission meetings** will be held **from March 24, 2026, to March 26, 2026**, in St. Leonhard near Salzburg, Austria.

In addition, we would like to provide you with the following information:

- **Applications for FIL grants**

We would like to take this opportunity to point out that **applications for FIL support or grants for events** must be submitted **exclusively through the respective FIL member association, signed either by the president and/or secretary general.** Applications to the FIL from (organizing) clubs or other organizations cannot be processed or considered.

- **Eurosport / Warner Bros. Discovery**

The FIL has entered into a cooperation agreement with Warner Bros. Discovery for the upcoming Olympic season regarding the broadcast of the Eberspächer Artificial Track World Cups both on linear TV (Eurosport) and as streaming on pay platforms (Discovery+). **This makes it possible to watch the FIL Eberspächer World Cups in Europe on linear TV and via streaming (Discovery+).** For streaming, Germany, Latvia, and Austria are geo-blocked for licensing reasons.

- **FIL Sport Integrity Unit**

The collaboration with Steve Harris ended on August 31, 2025. FIL Ethics Officer Karl-Friedrich Schauhoff will take over the tasks in this area on an interim basis. **The FIL's whistleblower hotline will be managed by Sportradar in the future.** This company works with proven and internationally networked specialists in the field of sports integrity and counts international (Olympic) sports associations among its clients.

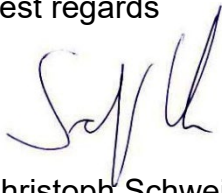
- **FIL photo platform SmugMug:**
