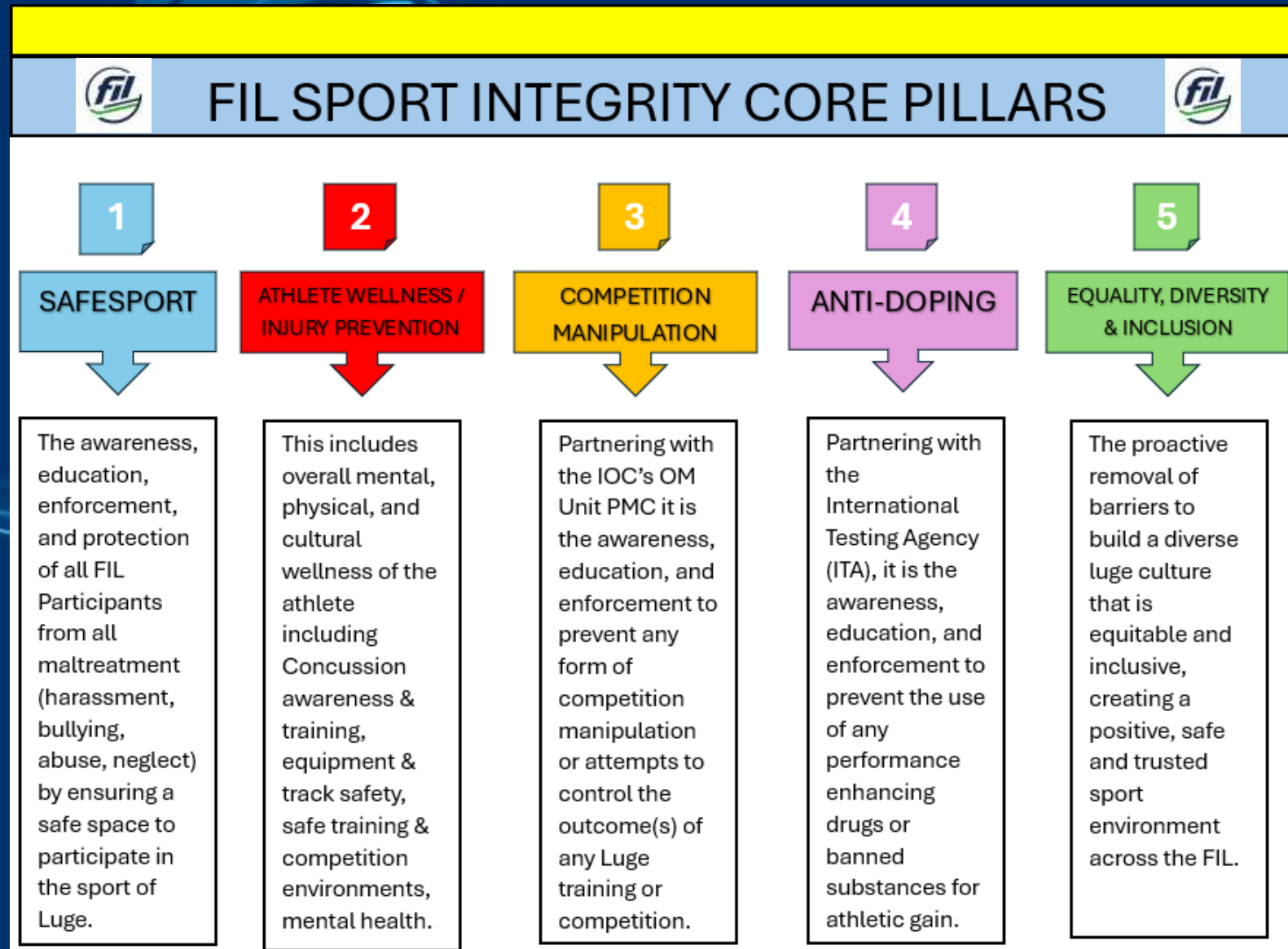
VISION

| MISSION |

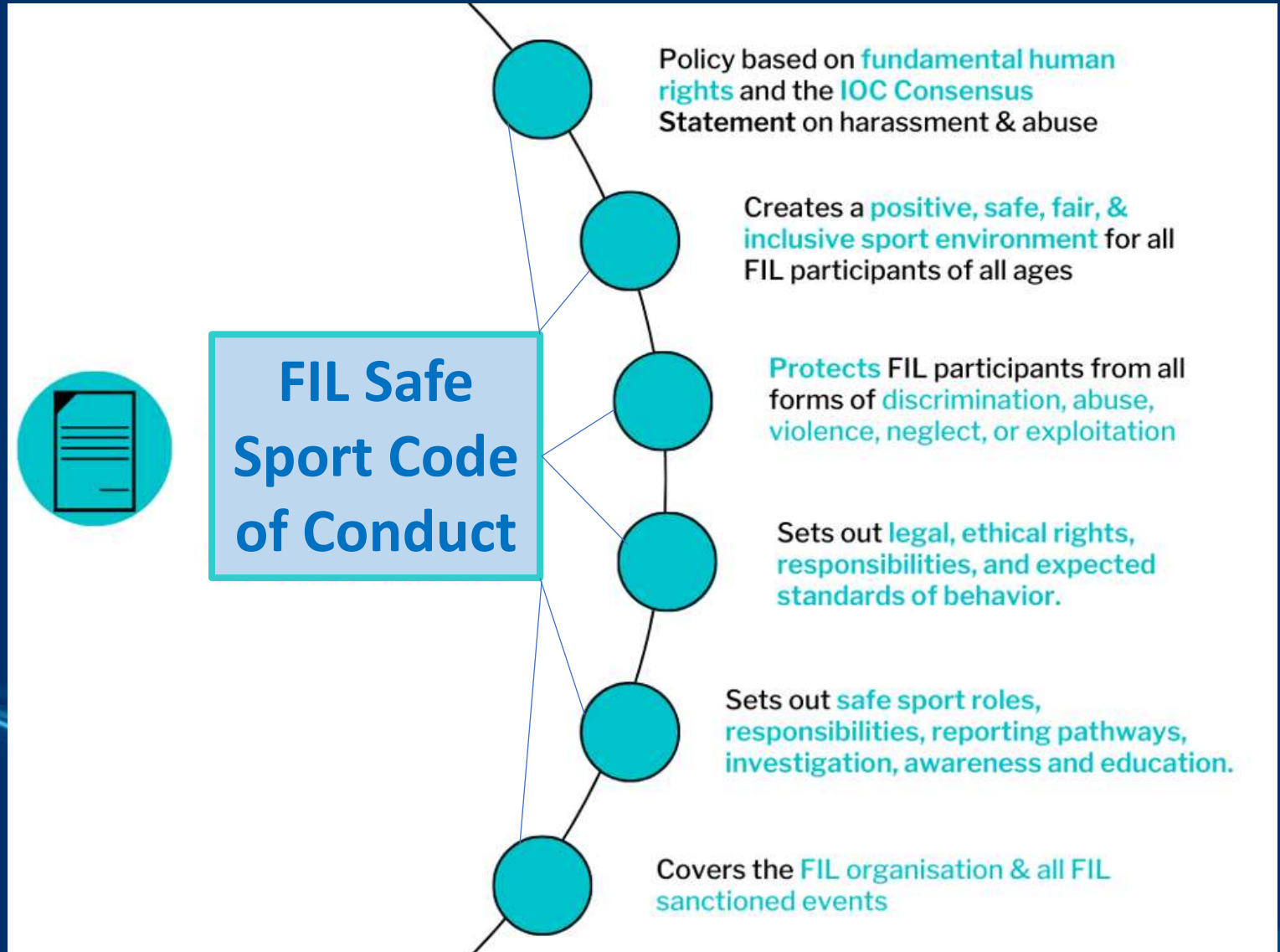

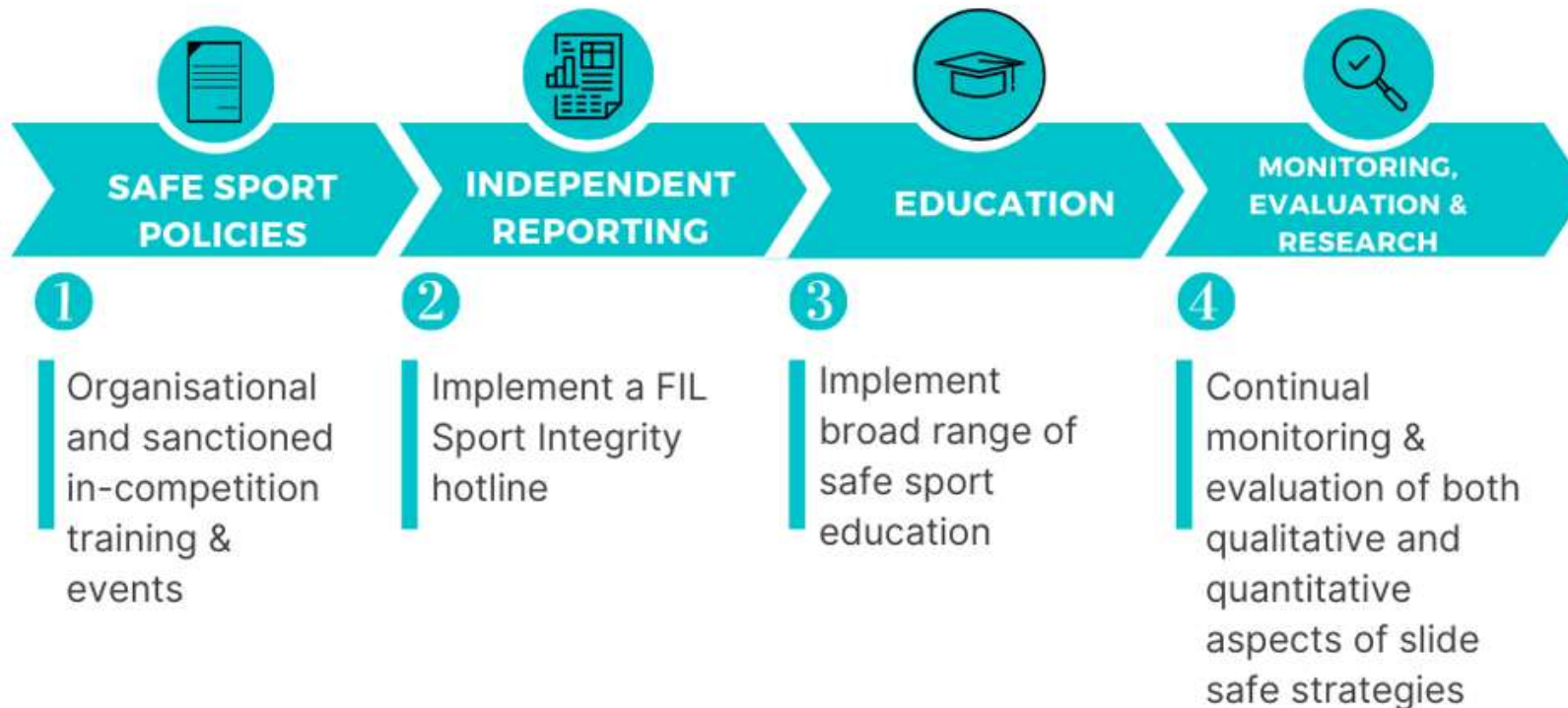
